ACCORD ENTRE LE GOUVERNEMENT DE LA RÉPUBLIQUE ITALIENNE ET LE GOUVERNEMENT DE LA RÉPUBLIQUE DE CÔTE D'IVOIRE SUR L'ANNULATION DE LA DETTE DE LA RÉPUBLIQUE DE CÔTE D'IVOIRE

Le Gouvernement de la République Italienne et le Gouvernement de la République de Côte d'Ivoire, guidés par l'esprit d'amitié et de coopération économique existant entre les deux Pays et en application du Procès -Verbal agréé relatif à la réduction de la dette de la République de Côte d'Ivoire, signé à Paris le 29 juin 2012 par les Pays participants à la réunion du Club de Paris, sont convenus de ce qui suit:

ARTICLE I

1. Le présent Accord concerne l'annulation de 100% du stock de la dette au 1^{er} juin 2012 se rapportant aux contrats conclus avant le 20 juin 1999, due par le Gouvernement de la République de Côte d'Ivoire à l'Italie par l'entremise de "SACE S.p.A. - Servizi Assicurativi del Commercio Estero".

En particulier, le présent Accord concerne l'annulation de:

- a) 100% de toutes les échéances dues entre le 1^{er} avril 2011 et le 31 mai 2012 inclus, au titre de toute la dette impayée à la date de la signature du présent Accord;
- b) 100% de toutes les échéances en principal dues entre le 1^{er} juin 2012 et le 1^{er} octobre 2039 à la date de la signature du présent Accord;
- c) 100% de tous les arriérés et 100% des intérêts de retard sur toute la dette impayée au 30 juin 2011. Ces intérêts de retard ont été calculés au taux de 3,46% pour les dettes dues à la SACE.
- 2. Les dettes concernées sont indiquées dans les Annexes au présent Accord. Ces Annexes pourront être modifiées d'un commun accord entre les Parties signataires du présent Accord.
- 3. Il est entendu que les contrats et/ou les conventions financières conclus après le 20 juin 1999 sont exclus de la présente annulation ou de tout autre futur réaménagement de la dette.

ARTICLE II

- 1. Dans le cadre de l'annulation de la dette susmentionnée le Gouvernement de la République de Côte d'Ivoire s'engage à:
- a) respecter les droits de l'homme et les libertés fondamentales et s'abstenir de l'emploi de la force comme moyen de règlement de différends internationaux;
- b) poursuivre le développement durable sur la base d'une stratégie nationale de la réduction de la pauvreté, conçue en consultation avec la société civile nationale et les partenaires internationaux;
- c) assigner au budget national des ressources destinées à des dépenses militaires n'excédant pas les besoins légitimes de sécurité et de défense du pays.
- 2. Le Gouvernement de la République de Côte d'Ivoire s'engage à soumettre au Ministère des Affaires Etrangères de la République Italienne, dans les trois mois à compter de la signature du présent Accord, le projet pour l'allocation des ressources (y compris les programmes d'investissement sectoriels) dégagées par l'annulation de la dette, conformément à la stratégie nationale de réduction de la pauvreté. Le projet doit être approuvé par les voies diplomatiques.

ARTICLE III

- 1. Le non respect des engagements prévus à l'Article II sera constaté par :
- a) les délibérations des Organisations Internationales (en particulier du Système des Nations Unies), de l'Union Européenne et des Institutions Financières Internationales;
- b) les estimations de conformité des dépenses militaires:
- c) les rapports officiels sur le progrès de la mise en œuvre du projet (y compris les programmes d'investissement sectoriels) mentionné à l'Article II, paragraphe 2.

ARTICLE IV

- 1. Au cas où les vérifications prévues à l'Article III indiquent que le Gouvernement de la République de Côte d'Ivoire ne respecte pas un ou plusieurs engagements prévus à l'Article II, le Gouvernement de la République Italienne demandera au Gouvernement de la République de Côte d'Ivoire d'entamer des consultations bilatérales. Ces consultations peuvent être remplacées, à la demande du Gouvernement de la République Italienne et là où applicable, par celles prévues à l'Article 96 de l'Accord de Cotonou entre les membres du groupe des Etats ACP et la Communauté Européenne et ses Etats membres. Au cas où le Gouvernement de la République de Côte d'Ivoire ne répondrait pas d'ici deux mois à la demande de consultations, ou si ces consultations s'avèrent insatisfaisantes en raison d'un grave manquement aux engagements prévus à l'Article II, le Gouvernement de la République Italienne peut décider de la suspension du présent Accord. Pendant la suspension, le Gouvernement de la République de Côte d'Ivoire des échéances programmées. les paiements responsable de tous sera précédemment et dues après la décision susmentionnée.
- 2. Une fois que les conditions prévues à l'Article II sont jugées rétablies, d'après les vérifications prévues à l'Article III, le Gouvernement de la République Italienne examinera la possibilité de lever la suspension.
- 3. Si, après une période adéquate de temps, les conditions prévues à l'Article II ne sont pas considérées comme rétablies selon les vérifications de l'Article III, le Gouvernement de la République Italienne dénoncera le présent Accord et la dénonciation aura effet trente jours après la notification à l'autre Partie.

ARTICLE V

A l'exception des dispositions du présent Accord, celui-ci n'affecte en rien les liens juridiques prévus par le droit commun, ou les engagements souscrits par les Parties pour les opérations auxquelles se référent les dettes mentionnées à l'Article I du présent Accord.

ARTICLE VI

Le présent Accord entrera en vigueur à la date de la signature et restera en vigueur jusqu'à l'achèvement du projet prévu à l'Article II, paragraphe 2.







ACCORDO

TRA IL GOVERNO DELLA REPUBBLICA ITALIANA E IL GOVERNO DELLA REPUBBLICA DELLA COSTA D'AVORIO SULLA CANCELLAZIONE DEL DEBITO DELLA REPUBBLICA DELLA COSTA D'AVORIO

Il Governo della Repubblica Italiana e il Governo della Repubblica della Costa d'Avorio, guidati dallo spirito di amicizia e di cooperazione economica esistente tra i due Paesi e in applicazione del Processo Verbale relativo alla riduzione del debito della Repubblica della Costa d'Avorio, firmato a Parigi il 29 giugno 2012 dai paesi partecipanti alla riunione del Club di Parigi, hanno concordato quanto segue:

ARTICOLO I

Il presente Accordo concerne la cancellazione del 100% del debito in essere al 1° giugno 2012 relativo ai contratti conclusi prima del 20 giugno 1999, dovuto dal Governo della Repubblica della Costa d'Avorio all'Italia per il tramite di "SACE SpA – Servizi Assicurativi del Commercio Estero".

In particolare, il presente Accordo riguarda la cancellazione di:

- a) 100% di tutte le rate comprese tra il 1° aprile 2011 e il 31 maggio 2012 incluso, su tutto il debito non rimborsato alla data di firma del presente Accordo;
- b) 100% di tutte le rate in conto capitale dovute tra il 1° giugno 2012 e il 1° ottobre 2039 alla data di firma del presente Accordo;
- c) 100% di tutti gli arretrati e degli interessi di ritardo sul debito dovuto al 30 giugno 2011. Tali interessi di ritardo sono stati calcolati al tasso del 3,46% per i debiti dovuti a SACE.
- 2. I debiti in questione sono riportati negli Allegati al presente Accordo. Tali Allegati potranno essere modificati di comune accordo tra le Parti firmatarie del presente Accordo.
- 3. Resta inteso che i contratti e/o le convenzioni finanziarie conclusi dopo la data del 20 giugno 1999 sono esclusi dalla presente cancellazione o da qualunque altra ristrutturazione futura del debito.

ARTICOLO II

- 1. Nel quadro della cancellazione del debito summenzionato, il Governo della Repubblica della Costa d'Avorio si impegna a:
 - a) rispettare i diritti dell'uomo e le libertà fondamentali e ad astenersi dall'impiego della forza come mezzo per risolvere le controversie internazionali;
 - b) perseguire lo sviluppo sostenibile nel quadro di una strategia nazionale di riduzione della povertà, elaborata di concerto con la società civile nazionale ed i partners internazionali;
 - c) destinare al bilancio nazionale risorse per scopi militari non eccedenti le esigenze legittime di sicurezza e difesa del Paese.

2: Il Governo della Repubblica della Costa d'Avorio si impegna a sottoporre al Ministero degli Affari Esteri della Repubblica Italiana, entro tre mesi dalla firma del presente Accordo, il progetto relativo alla destinazione delle risorse (compresi i programmi di investimento settoriali) rese disponibili a seguito della cancellazione del debito, conformemente al documento di strategia nazionale di riduzione della povertà e la crescita. Il progetto dovrà essere approvato per le vie diplomatiche.

ARTICOLO III

Il non rispetto degli impegni previsti all'Articolo II sarà verificato secondo:

- a) le deliberazioni delle Organizzazioni Internazionali (in particolare del Sistema delle Nazioni Unite), dell'Unione Europea e delle Istituzioni Finanziarie Internazionali;
- b) le valutazioni sulla congruità delle spese militari;
- c) i rapporti ufficiali sui progressi conseguiti nell'attuazione del progetto (compresi i programmi di investimento settoriali) di cui all'Articolo II, paragrafo 2.

ARTICOLO IV

1. Qualora dalle verifiche previste all'Articolo III risultasse che il Governo della Repubblica della Costa d'Avorio non ha adempiuto ad uno o più impegni previsti all'Articolo II, il Governo della Repubblica Italiana chiederà al Governo della Repubblica della Costa d'Avorio di avviare delle consultazioni bilaterali.

Tali consultazioni potranno essere sostituite, su richiesta del Governo della Repubblica Italiana, e ove applicabili, da quelle previste all'Articolo 96 dell'Accordo di Cotonou tra i membri del gruppo degli Stati ACP e la Comunità Europea ed i suoi Stati membri.

Qualora il Governo della Repubblica della Costa d'Avorio non rispondesse entro due mesi alla richiesta di consultazioni, o se queste ultime si rivelassero insoddisfacenti rispetto ad una grave inosservanza degli impegni di cui all'Articolo II, il Governo della Repubblica Italiana potrà decidere la sospensione del presente Accordo.

Durante la sospensione, il Governo della Repubblica della Costa d'Avorio sarà responsabile di tutti i pagamenti delle rate programmate in precedenza e dovute dopo la suddetta decisione.

- 2. Nel momento in cui le condizioni previste all'Articolo II verranno considerate ristabilite, in base alle verifiche previste dall'Articolo III, il Governo della Repubblica Italiana valuterà la possibilità di togliere la sospensione.
- 3. Se, dopo un congruo periodo di tempo, le condizioni di cui all'Articolo II non verranno ritenute ripristinate in base alle verifiche di cui all'Articolo III, il Governo della Repubblica Italiana denuncerà il presente Accordo e la denuncia avrà effetto trenta giorni dopo l'avvenuta notifica all'altra Parte.

ARTICOLO V

Fatte salve le sue disposizioni, il presente Accordo non pregiudica in alcun modo i vincoli giuridici previsti dal diritto comune o gli impegni sottoscritti dalle Parti per le operazioni cui si riferiscono i debiti menzionati all'Articolo I del presente Accordo.

ARTICOLO VI

Il presente Accordo entrerà in vigore alla data della firma e rimarrà in vigore fino al completamento del progetto di cui all'Articolo II, paragrafo 2.

In fede di che, i sottoscritti Rappresentanti, debitamente autorizzati dal rispettivo Governo, hanno firmato il presente Accordo.
